Ashley Grayson, a 35-year-old entrepreneur and self-proclaimed “eight-figure business coach,” was sentenced to 10 years in federal prison for orchestrating a chilling **murder-for-hire** (<https://shaneatrajonespeaks.com/tag/murder-investigation/>) scheme. The **Dallas resident** (<https://shaneatrajonespeaks.com/tag/texas/>) attempted to hire a Memphis couple to **murder three individuals** (<https://shaneatrajonespeaks.com/tag/murder/>) she viewed as threats: a business rival from Southaven, Mississippi, a former boyfriend, and a Texas woman who criticized her online.

Grayson gained online fame by selling business courses and flaunting her lifestyle as a successful philanthropist. However, her rivalry with the Southaven woman, who operated a similar online business, escalated dramatically. Believing the woman created fake profiles to tarnish her reputation, **Grayson decided to take drastic and illegal measures.**

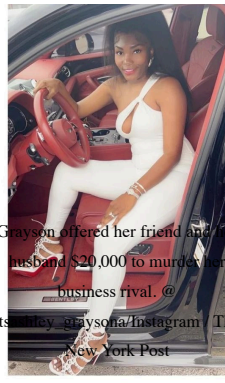

She showcased her opulent lifestyle online, sharing images of her North Carolina mansion, lavish vacations, and even a yacht proposal featuring a private serenade by R&B legend Monica, as reported by Yahoo. Grayson also earned praise for her philanthropy. ## The Fuse That Lit the Flame: The Ashley Grayson Murder-for-Hire Case

According to Atlanta Black Star (<https://atlantablackstar.com/2024/04/05/social-media-influencer-and-entrepreneur-ashley-grayson-found-guilty-in-murder-for-hire-scheme/>), the explosive feud that ultimately led to Ashley Grayson's conviction in a murder-for-hire scheme can be traced back to an escalating series of public disputes, particularly with financial coach Derricka Harwell.

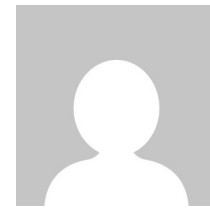

The feud began after Grayson accused Harwell of defamation following a comment Harwell made under one of Grayson’s Facebook posts. Grayson’s lawsuit alleged that Harwell’s words were “**false, defamatory, and injurious**” to her personal reputation. The financial coach’s post reportedly claimed that Grayson had “**stalked and harassed**” her online, which Grayson argued severely damaged her image both on social media and in the real world.

In an exhibit obtained by the Atlanta Black Star Derricka Harwell alleged social media comment stated:

“Chile, I had to get legal and file a whole restraining order on this one... it ain’t what you think. I promise. Be careful who you show admiration to sis....I bet a million dollars this ain’t it.”

Grayson’s legal battle with Harwell didn’t end there. As part of the defamation lawsuit, Grayson claimed that Harwell’s comment permanently tarnished her reputation, making people believe false allegations about her character. These claims reflected the growing tension between the two women and set the stage for a darker turn in Grayson’s life.

This public dispute was one of the key factors that prosecutors highlighted in their investigation into the murder-for-hire scheme. Federal authorities revealed that Grayson had hired a contract killer in Tennessee, paying the individual to murder a person—referred to only by the initials D.H.

The details of the plot remain murky, as many court records are sealed. However, a video surfaced online that allegedly shows Grayson speaking to another woman about “Derricka,” further fueling suspicions that the feud played a pivotal role in motivating the crime. While it is not confirmed that the video is directly connected to the murder-for-hire plot, it does suggest a deeper, unresolved anger linked to Harwell.

## Ashley Grayson's Settlement Allegations

The [Atlanta Black Star](https://atlantablackstar.com/2024/04/05/social-media-influencer-and-entrepreneur-ashley-grayson-found-guilty-in-murder-for-hire-scheme/) (<https://atlantablackstar.com/2024/04/05/social-media-influencer-and-entrepreneur-ashley-grayson-found-guilty-in-murder-for-hire-scheme/>) also reported that Grayson’s rise to fame was overshadowed by controversy. Although she gained popularity through her business venture, *Digital Course Recipe*, **which allegedly earned her over \$1 million in under an hour**, critics soon questioned the authenticity of her financial success.

Some accused Grayson of inflating her earnings and claimed that the bulk of her wealth came from a workers’ compensation settlement after she lost a finger at a previous job. This revelation only added to the growing animosity surrounding Grayson, culminating in accusations from an alleged victim who claimed that **she was scammed out of \$2,000** after purchasing Grayson’s course, only to be blocked online when she sought a refund.

## The Murder-For-Hire Proposal

In August 2022, Grayson invited a Memphis woman and her husband, former associates of hers, to Dallas under the guise of discussing a lucrative **“business opportunity.”** According to (<https://www.justice.gov/usao-wdtn/pr/texas-woman-sentenced-10-years-imprisonment-connection-murder-hire-plot>) Reagan Fondren, Acting U.S. Attorney for the Western District of Tennessee, Grayson approached a Memphis woman and her husband in 2022, **offering them \$20,000 each** to murder three people:

1. A Southaven businesswoman who ran a similar online enterprise and whom Grayson accused of creating fake profiles to discredit her.
2. Her ex-boyfriend, for reasons not disclosed publicly.
3. A Texas woman who posted negative comments about her on social media.

Grayson allegedly offered a \$5,000 bonus if the Southaven woman was killed within a week.

The Memphis couple recorded a subsequent call in which Grayson reiterated her intentions. Rather than executing the plan, the couple staged evidence of a failed attempt, sending Grayson a photo of police lights to claim the job had been interrupted. They then extorted \$10,000 from Grayson as partial payment.

## The Investigation and Trial

Grayson’s actions came to light through the couple’s cooperation with law enforcement, including the FBI and the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF). Following a comprehensive investigation, a [federal grand jury indicted](https://www.justice.gov/usao-wdtn/pr/texas-woman-sentenced-10-years-imprisonment-connection-murder-hire-plot) (<https://www.justice.gov/usao-wdtn/pr/texas-woman-sentenced-10-years-imprisonment-connection-murder-hire-plot>) Grayson and her husband, Joshua Grayson, in 2023 for the use of interstate facilities in the commission of murder-for-hire under 18 U.S.C. §1958.

During the March 2024 trial, Joshua Grayson was acquitted, while Ashley was convicted. On October 31, 2024, U.S. District Judge Thomas L. Parker sentenced her to 120 months, the maximum penalty under federal law, along with three years of supervised release. In federal cases, parole is not an option.

## Latest Update on Ashley Grayson

According to a report from *Say Cheese* ([https://x.com/SaycheeseDGTL/status/1852161209232929047?t=wX\\_xWiQY2wJmV4L6s0nMXw&s=19](https://x.com/SaycheeseDGTL/status/1852161209232929047?t=wX_xWiQY2wJmV4L6s0nMXw&s=19)) on October 31, 2024, Ashley Grayson, who is currently pregnant with her third child, has four weeks to report to prison to begin serving her sentence. As she prepares for her incarceration, many are left wondering how this will impact her family, business, and the ongoing public conversation surrounding her criminal conviction.



# A Cautionary Tale

Acting U.S. Attorney Reagan Fondren called the case a **“twenty-first-century crime”** where online disputes spilled into the real world. “The emotional toll on the victims and their families is immeasurable,” Fondren said.

“This was a twenty-first century crime where online feuds and senseless rivalries bled into the real world. The defendant tried to hire someone to murder a woman over things that happened exclusively on the internet. Fortunately, no one was physically hurt in this case, but the victim and her family still felt a severe and emotional impact as the result of the defendant’s actions. The proactive response from the investigating agencies and our prosecutors prevented an even more serious crime from occurring.”

Special Agent Joe Carrico of the FBI Nashville Field Office added, **“This case demonstrates our commitment to investigating violent crimes and holding perpetrators accountable.”**

## The Public and Social Media Reaction

The case has been a hot topic on social media platforms, igniting debates within Facebook groups and online communities dedicated to discussing the details and unfolding drama surrounding the incident. The case has also raised questions about the power of internet fame and its impact on real-life events.

While the identities of the other two victims have been widely shared on social media, with videos and posts revealing their stories, major news outlets have yet to name them for legal and safety reasons. As a result, I won’t be naming them here out of respect for their privacy, but if you’re curious, you can explore more details online.

This case highlights the growing influence of social media and the unintended consequences that come with public exposure, serving as a powerful lesson for both influencers and followers alike about the risks and responsibilities tied to fame.
